RIGHT OF WAY STATS

Diamond has been involved in right-of-way acquisitions since the company's beginning, but has hit full stride in recent years. Since 2010, Diamond has acquired rights of way on behalf of various producers and midstream companies on 32 gathering systems from origination in Western ND and Eastern MT totaling over 2100 miles. We have also added 750 miles of extensions and loop lines to clients' previously existing systems in the Bakken region. The systems include crude, natural gas, freshwater and saltwater. Diamond has also completed right-of-way projects for various public utilities including power line and water supply systems.

We have recently completed acquisition for a 238 mile multi-state crude oil transmission line.
